- If the shareholder votes in advance by proxy, the power of attorney shall be enclosed to this form. If the shareholder is a legal entity, a registration certificate or a corresponding document for the legal entity shall be enclosed to the form.
- **Please note that a shareholder whose shares have been registered in the name of a bank or securities institute must register its shares in its own name to vote. Instructions for this is included in the notice convening the Meeting.**
- If a shareholder does not intend to exercise its voting right by way of advance voting, the form for advance voting should not be submitted.
- A shareholder cannot give any other instructions than selecting one of the options specified at each point above. If a shareholder wishes to abstain from voting in relation to a matter, kindly select "Abstain". A vote is invalid if the shareholder has provided the form with specific instructions or conditions or if pre-printed text is amended or supplemented. One form per shareholder will be considered. If more than one form is submitted, the form with the latest date will be considered. The form latest received will be considered if two forms are dated at the same date. An incomplete or wrongfully completed form may be discarded without being considered.
